As per provision of section 65(4) of Maharashtra University of Health Sciences Act 1998, I am directed to inform you that, on the basis of Local Inquiry Committee report and permission from Academic Council vide Resolution No. 388/2025 dated 23/09/2025 the Hon'ble Vice Chancellor is pleased to grant First Time Affiliation to **Antyoday Institute of Ayurvedic Medical Sciences and Research Institute, Devgram, Tal. However, the affiliation is subject to the following conditions : -

- 11) Fulfilment of norms and conditions laid down by Central Council of Indian Medicine / National Commission for Indian System of Medicine, (NCISM) and Govt. of India.
- 12) Rules and Regulations made by the Govt. and the University, as amended from time to time, will be binding on the College.
- 13) The college should obtain the permission for admitting the students from the Admission Regulating Authority, Mumbai.
- 14) The college should obtain approval of fee schedule for the admission of the students from the Fee Regulating Authority, Mumbai.
- 15) The college should obtain approval / recognition of teachers from Maharashtra University of Health Sciences, Nashik.

- 16) This First Time Affiliation to start B.A.M.S. (UG) course with 60 intake capacity is valid for Academic Year 2025–26 only.
- 17) The next batch of students shall not be admitted unless Continuation of Affiliation of MUHS, is obtained by college/Institute.
- 18) The college shall not admit the students for the Academic Year 2025-26 after the cut-off date prescribed by the CCIM / (NCISM), New Delhi.
- 19) The students shall be admitted only after obtaining the permission of concern council & competent Authority of the State Govt.
- 20) It is mandatory for the College / Institute to register on AISHE portal and submit the required data on AISHE portal time to time.
